## CMA CGM starts gradual return to Suez Canal

The Suez Canal is set to gradually resume its full capacity, as conditions for improved security in the Red Sea region start to be created following the ceasefire agreement in Gaza and Houthis pledge to limit their attacks on non-Israeli ships. Adm. Ossama Rabiee, Chairman of the Suez Canal Authority, emphasised the canal's readiness to accommodate these returning services. French liner major CMA CGM has emerged among the first shipping lines that are resuming transits through the Suez Canal following the ceasefire, signalling what is hoped to be the beginning of a gradual return to normalcy for the vital waterway. Rabiee said that starting January 23, several CMA CGM vessels are set to transit the canal as part of the EPIC (Europe Pakistan India Consortium) service between South Asia and Europe. The weekly service includes 13 ports of call and a vessel fleet of 13 container ships, including those from COSCO and OOCL.

According to Rabiee, the Suez Canal Authority continues to enhance its capacity and services, including the completion of a new 10-kilometre channel at the southern end of the canal. The expansion increases the length of the two-way section of the canal from 72 kilometres to 82 kilometres, which is expected to improve the canal's capacity by allowing the passage of an additional 6 to 8 ships per day. The project also aims to enhance navigation efficiency and increase the canal's ability to manage potential emergencies. The commercial operation of the new channel is set to start in the first quarter of 2025.

# MSC starts feeder service connecting Vizhinjam transshipment terminal with Haldia Dock Complex

MSC, the world's biggest container shipping line, has started a feeder service linking Haldia Dock Complex of state owned Syama Prasad Mookerjee Port Authority with the newly opened container transshipment terminal at Vizhinjam in Kerala. The containers originating and bound for Kolkata/Haldia trade were earlier transhipped through Colombo port, a regional transshipment hub. The service to be run every ten days is the first feeder service to be launched between an Indian gateway port and the Vizhinjam transshipment port after India constructed a transshipment facility to cut dependence on Colombo port for sending and receiving containers. The 'Haldia Shuttle' service will also halt at Paradip port enroute to Vizhinjam. At both Haldia and Paradip ports, the feeder service will call at the terminal run by J M Baxi Ports & Logistics Ltd. The Vizhinjam container transshipment facility has drawn the most ship calls from MSC since it began operations, initially on a trial basis in July 2024 and then launching full-fledged commercial operations in December. The terminal handled almost one lakh TEUs during the trial period, which ran from July to November.

According to estimates, Colombo, Singapore, and other regional ports tranship about 3 million TEUs of cargo containers heading for India each year. Over 85% of this is handled by Colombo, Singapore, and Port Klang, with Colombo alone handling roughly 2.5 million TEUs. Transshipment of cargo leads to logistical cost inefficiencies for Indian industry because of the additional port handling fees that are incurred at the transshipment hubs. Sources noted that the extra port handling costs, which amount to \$80–100 per TEU, might be avoided if the container was imported or exported as direct gateway cargo rather than being transhipped.

## Yards 'choked with boxes' as congestion returns to Colombo

A nagging capacity strain at Sri Lanka's Colombo port, which caused considerable congestion issues in early 2024, has come back to haunt container lines and shippers using the busy South Asia hub. A confluence of factors seems to have contributed to the latest bout of disruption, with fears the delays will last at least through the month, according to industry sources in Colombo. "Inter-terminal activity is painfully slow, and yards are alarmingly choked with containers," one ship agent said. Brisk inter-terminal transfers (IITs) are critical for container transhipment operations. The source noted: "Vessels are often incurring delays of up to three days to berth." With no specific official updates on the logjam, sources believe sporadic vessel bunching and some slackness by importers in picking up cargo after Customs' intensified inspections have added to the capacity pressure at the port.

#### Travel Diaries - Mana Pools National Park, Zimbabwe



Mana Pools National Park is in the far north of Zimbabwe. It includes the south bank and islands of the Zambezi River, which forms the border with Zambia. The park is known for wildlife visibility beside the river and in the flood plains. Large populations of elephants, hippos and Nile crocodiles gather at sunrise in the Long Pool. In the park's south, lions wait for prey around the waterhole at Chitake SpringFew places in Africa are as wild. "Elephants shake the acacia trees to dislodge pods to munch, lions roam in huge prides hunting big herds of buffalo, crocodiles grow to five metres, and hippos still rule the rivers,".

Off Beat News - Homewoner Removes Doors and Windows After Tenants Stop Paying Rent



A landlord in northern France is trying to force his tenants to leave in the middle of winter by removing the doors and windows on his property. In France, as in many European countries, it's illegal to evict tenants in wintertime, even if they are behind on rent. However, one landlord in Pas-de-Calais, a department in northern France, is trying to skirt around the law by forcing his tenants to vacate the property without actually asking them to leave. On December 20th, a team of workers arrived at the property and started disassembling the doors and windows under the pretext of replacing

them. However, the tenants claim that they just loaded up the old doors and windows in a car and drove away, leaving them to brave the cold and face potential intrusion at all hours of the day and night.

The tenant, a mother of one, told sources that she tried reaching out to the landlord after the incident, but they have been unreachable. Left with no other option, the woman barricaded the windows and doors with cardboard. She claims she is too terrified to leave the property now, so she spends all of her time at home. Contacted by French media, the landlord took responsibility for their actions, admitting to having the doors and windows on her property removed, adding that she only did it because the tenant failed to keep up their end of the bargain.

"They didn't insure the house. In fact, we had agreed together that she would pay. She owes me five months' rent," they told France Info. The French Homeowners' Association told reporters that they understand the landlord's motives, adding that the method used to coerce the tenants into leaving the property is completely illegal. The tenant has filed a complaint for breach of trust and is looking for social housing.
